AN ORDINANCE MAKING AND LEVYING 2020 ANNUAL TAX LEVIES AND AUTHORIZING FISCAL YEAR 2022 EXPENDITURES IN AND FOR THE CITY OF PARSONS, LABETTE COUNTY, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF PARSONS, KANSAS:

SECTION 1. That the following taxes for 2021 are hereby levied and spread over all real, personal, and mixed property within the corporate limits of the City of Parsons, Kansas, as shown by the assessed valuation of \$54,524,946 for the purpose of maintaining the different funds, and authorizing fiscal year 2022 expenditures as herein specifically set out and described of the City of Parsons, Kansas, from January 1, 2022 to and including December 31, 2022.
